- More importantly, are we measuring and reporting on what matters to the public (as patient, taxpayer, informed citizen)?



The Health Council of Canada

- Key accountability measure in the 2003 First Ministers' Accord on Health Care Renewal
- Mission: To monitor and report to Canadians and their governments on best practices and innovation, and progress on health care renewal in Canada
- Key accord measures:
 - Timely access, quality, sustainability, health status & wellness



Measuring performance in Canada



- 14 different health care systems
- Diverse populations with diverse health needs
- Lack of overarching framework and systematic approach to performance reporting
- Health indicator ‘chaos’
- Minimal emphasis on ‘the patient’

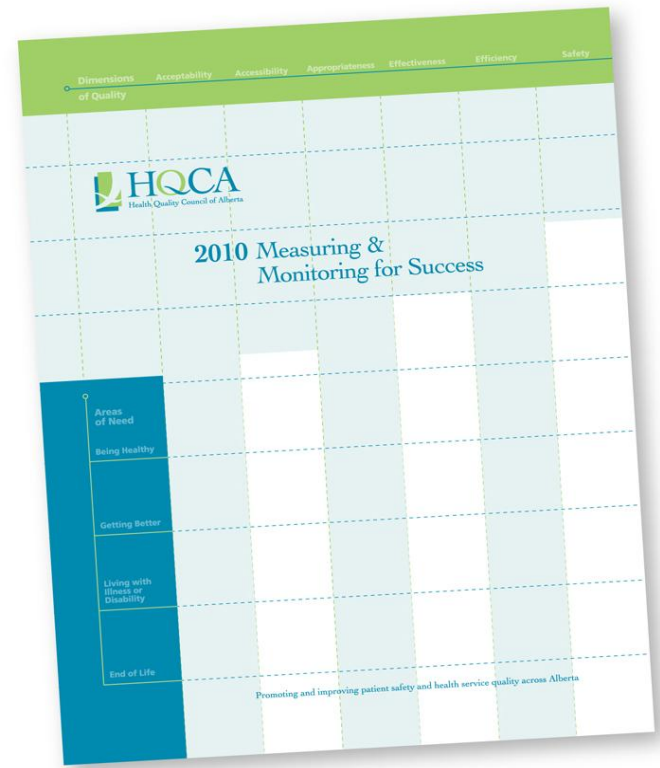

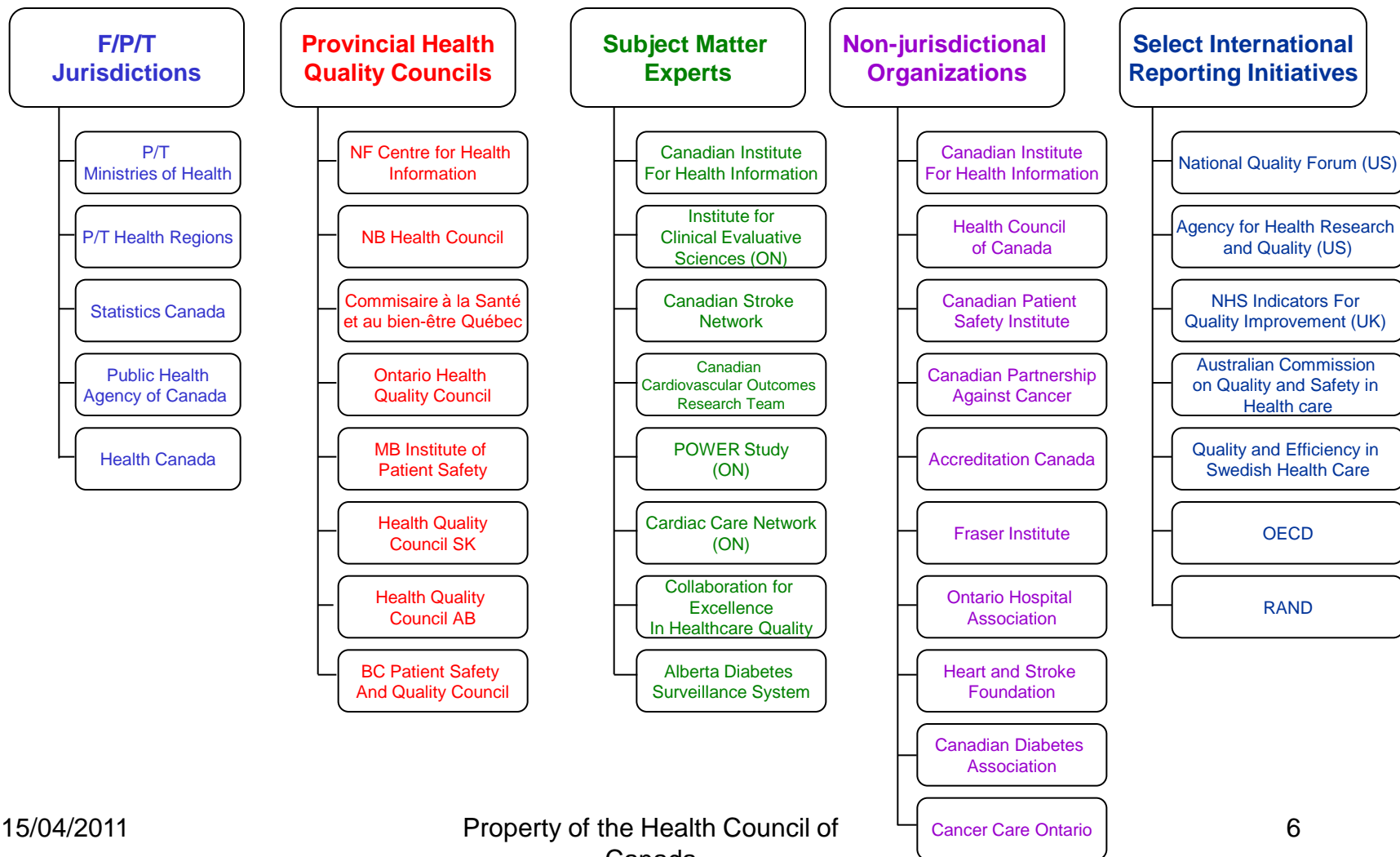

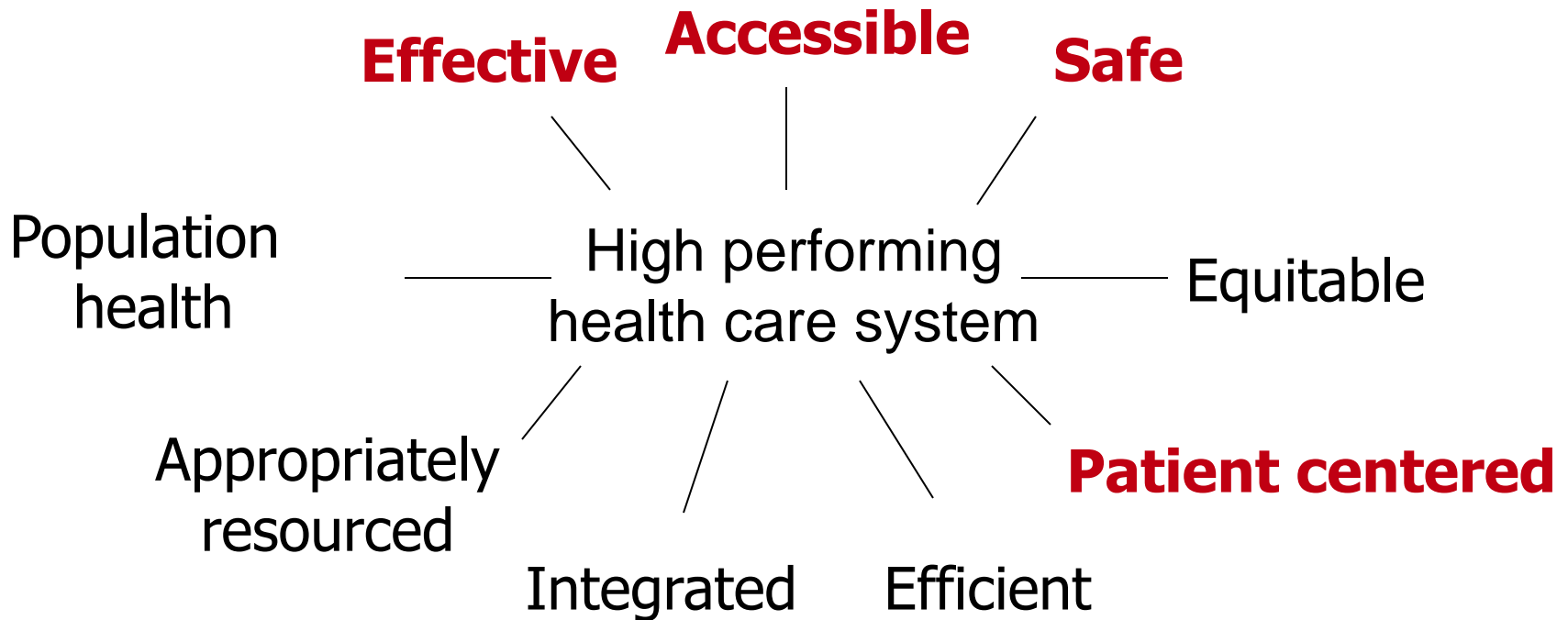


2011 Indicator Chaos

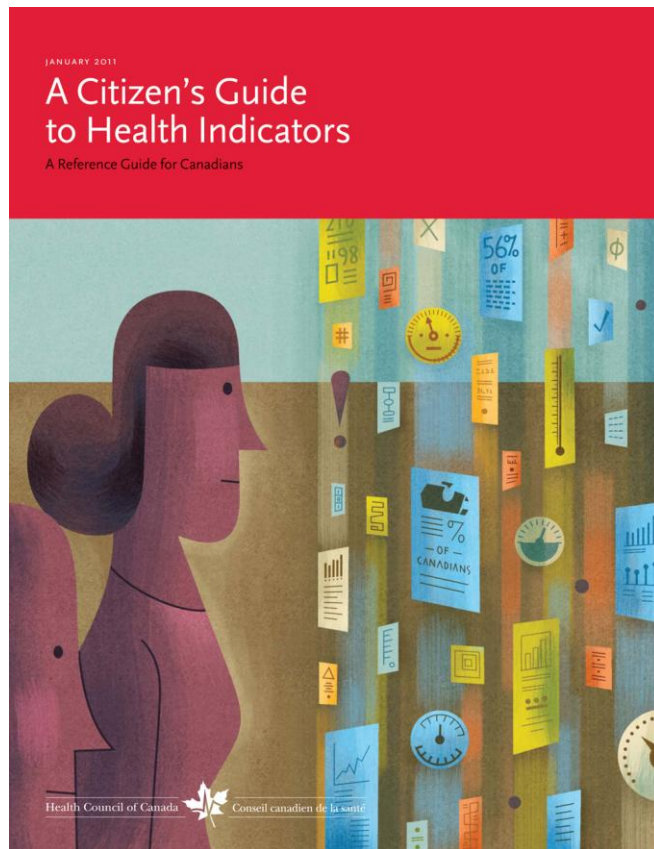


What the Canadian public is saying





A Citizens' Guide to Health Indicators



- To build health literacy -- the ability to access, understand and use information for health decision-making purposes
- Designed to share understanding of the importance and use of health indicators



Some questions on our agenda

- Where is the patient in system thinking and design?
- How does the system better engage patients, and how will we know if we are successful?
- Will we be better able to report on best practices and progress in health care renewal in a way that makes sense to the public?





Levels of patient engagement

Diverse and can occur at various levels in the health care system

PERSONAL CARE

Patient and health care provider



Individual patient/family and their provider/care team discussing decisions regarding treatment and ongoing care

PROGRAM OF CARE

Patient as part of a planning group



Groups of patients with a common interest involved in planning for the organization and delivery of specific health services, such as regional cancer services

SYSTEM OF CARE

Citizen as part of an engagement strategy



Citizens providing input into planning or evaluating a broad range of health services or policy, for example through a survey of a public forum



Building an engagement indicator at the personal care level?

- How often are you involved to the extent that you want to be in decisions related to your care?
- How often do you have enough time with your physician?
- How often do you have the opportunity to ask questions about your recommended treatment?




Conclusion

- To bridge the gap between the system and the public perspectives, we must do better individually and collectively in health system reporting by focusing on:
 - Relevance
 - Comparability
 - What matters to the public

Over half of Canadians surveyed feel that fundamental changes are required to make the system work better.
